BUILDING BYLAW FEES

- Refundable building deposit for new development: \$1,000.00

For all new development (does not include changes to pre-existing development), there is a refundable building deposit of \$1,000.00. A refund of 100% of the building deposit will be issued to the Developer when all of the conditions below have been met.

The Municipality must be provided with:

1. Receipt of Final Inspection of the building before occupancy.
2. Completion of all deficiencies.
3. Receipt of Real Property Report
4. Confirmation of inspection of water, sewer and metre service connection by the municipality.
5. Confirmation of the installation of a water and sewage back flow preventer.

In any event, if the above items shown above are not completed within 24 months from the date of the approved development, the deposit shall be forfeited to the Municipality. Any refunds will be issued by way of cheque by the local authority.

COUNCIL PROCEDURES POLICY

315.2015 Collis/Senick - That due to public perception and workplace conflict or difficulties, no member of council shall be appointed to any committee or board whereby they are involved in an intimate relationship with an employee or contractor that is involved in any manner with the same committee or board; FURTHER, no member of council shall be appointed to any committee or board whereby the same employee or contractors' supervisor or subordinate(s) are also involved in any manner with the same committee or board; FURTHER, 'intimate relationship' be defined as immediate family or romantic and that this policy be added to the Council Procedures Bylaw.

CULVERT POLICY

316.2015 Collis/Arndt - That the following culvert policy is approved and updated in the policy manual:

If no existing culvert - all costs of the culvert and installation is the responsibility of the property owner or agent. All culvert installations must be inspected by the Public Works and Utilities Department before being covered. An appointment for inspection should be made at least 72 hours in advance.

If an existing culvert needs to be repaired or replaced due to natural causes, the Town bears the cost which includes repair to the driveway, if required, back to a useable condition. Should the culvert require repair or replacement due to damages by the property owner, all costs will be charged back to the owner. New and replacement culverts are to be made of HDPE material or other material as only approved by the Public Works Department.
