Al (Allah Ditta Butte) never imagined he would have two businesses in Dundurn, but a year and a half ago he did just that. Already the owner of Dundurn Auto, his dream of - again - owning a restaurant is becoming a reality.

Al isn't a stranger to the food industry. Prior to moving to Saskatchewan he resided in Toronto where he owned a fish and chip restaurant. When he purchased his second property in Dundurn, he applied for a discretionary zoning permit to allow a mixed use of commercial and residential.

Al started renovations from the ground up, in what was a former garage at the residential property. On December 20th the building was packed with contractors, tile setters, carpenters, and most importantly, the pizza oven. It was being installed as mechanics worked to ensure the oven was

working efficiently.

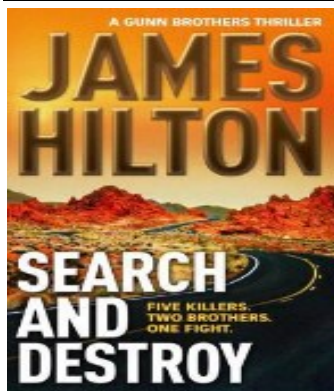
Al's business partner Muhammad Shahid (left), will start as the restaurant manager and has been busy training in Calgary on all aspects of making a great pizza pie.

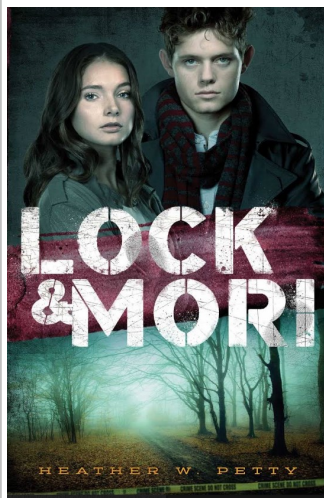

**MAYOR- PER VINDING**

Happy New Year everybody,

Here we are at the end of the year and getting ready to start a new year. By the time this gets printed Christmas will have come and gone. I hope you had a blessed time over the Christmas season.

I hope you have taken the time to fill out the survey regarding a new rink. Check with the Town Office if you have any questions.

We are in the process of getting some land across the highway annexed into the Town. The owners of the land requested the annexation as they have plans for development on that land.

It is nice to see the rink in full swing. Seems when I go for a walk with my dog that there is always someone at the rink. Good to see.

I thought you might find the following story interesting. Here is a story about ten people who go to a restaurant every day to have dinner. The combined bill for all the meals totals \$100 and they all agree to share the bill in the same proportion that taxes are paid. The first four -the poorest- therefore pay nothing. The fifth

person has to pay 1 dollar, the sixth 3 dollars, the seventh 7 dollars, the eighth 12 dollars and the ninth 18 dollars. The tenth, the richest of them all has to pay 59 dollars.

That's how they eat together every day and they are all happy about the way the bill is shared. Right up to the time the restaurant manager decides to give them a rebate. "Since you are such good customers", he says, "I am giving you a discount of 20 dollars on your total bill." After this, a meal for ten people now costs \$80. The group would like to continue to pay the bill in the same proportion taxes are paid. So the first four are not affected. They still do not have to pay.

But what about the other six who pay? What should they do? How do you share the discount of 20 dollars so every one gets an equal share?

Now you need to pay attention.

They find out that \$20 divided by 6 is \$3.33. If they subtract that amount from each person's share, the fifth and sixth person get paid for eating. The manager suggests that the most reasonable way would be to reduce each person's bill equally so he sits

down to calculate what each person's bill would be.

The result is that the fifth person would also eat for free, the sixth person pay 2 dollars, the seventh person 5 dollars, the eighth 9 dollars, the ninth 12 dollars and the tenth person pays 52 instead of 59. All six people get a lower amount to pay and the first four still eat for free.

Then one of them starts to compare what each one has saved. They are standing outside the restaurant. "I only got 1 dollar of the 20" says the sixth person, pointing to the tenth person, "but you got 7 dollars." "Precisely" says the fifth person. "I saved only 1 dollar. It is unfair that he got 7 times as much as me". "That's true" says the seventh person. "Why should he get 7 dollars when I only got 2 dollars? The rich always have it better." "Just a minute", say the first four. "We got absolutely nothing. This system takes advantage of the poor." The nine people surround and beat up the tenth person.

Next day he doesn't come for dinner, but the other nine sit down at the table and eat without the tenth person. When the bill arrives they discover something.....There's 52 dollars missing. Until next time, have a great day, eh? And God Bless



Making Theater Happen

Hanley High School's Drama Club has started rehearsing for their upcoming play "Bluebeard's Chamber" written by local playwright Leanne Griffin (pictured above).

Leanne, who has a Master's in Drama is passionate about performing and directing and has been doing so for the past 20 years. Under her belt are 13 Sask Drama Association awards for Best Overall Production at Regionals and 3 SDA awards for Best Overall Production at Provincials (*The History of Dating* 2006, *Dust* 2016, and *The Hotel* 2017).

Leanne started writing her new play "Bluebeard's Chamber" in June of

2017. She attended the Sage Hill Writing Retreat in Lumsden Saskatchewan in July and completed her first draft within 10 days, then immediately began to work on her second draft. Leanne and her entourage of high school actor's explained that "Bluebeard's Chamber" alludes to the fairy tale of a man with a blue beard who has dark secret's and is set in an escape room with a group of friends. But they refrain from giving out too much detail about the play, only hinting that this year's play will be a drama, but with elements of humour as well.

As Leanne wrote the play she kept her six returning student actors in mind for the roles she created, and auditioned for the three remaining characters on November 20th. The production has been a work in progress; rehearsals are underway, as well as stage production and teaching the new actors about motivation, characterization, and blocking. Hanley teacher Brandon Hutchinson is assisting Leanne with directing for the third year in a row.

This years production is made up of nine actors and five techs from grades 8 - 12. Their first performance is scheduled for March 12th at Hanley School with tickets sold at the door, and their second performance will be a Dessert Theatre on March 13th with pre-purchased ticket sales only.

December Report from the Legislature:

During the fall sitting, our government moved to:

- Fulfill its commitment to provide individualized funding to children under six with Autism Spectrum Disorder;
- Improve the rate of organ donation in the province through a new program led by donor physicians;
- Continue reducing health care administration costs through the consolidation of the province's 12 regional health authorities into a single Saskatchewan Health Authority;
- Introduce legislation to facilitate the federal government's legalization of the use of non-medical marijuana, even though the province continues to

have concerns about the federal government's rushed timetable;

- Work with municipalities to allow ride sharing-services like Uber and Lyft to operate in Saskatchewan;

- Amend *The Privacy Act* to allow greater protection against the unauthorized electronic distribution of intimate images;

- Create a process to improve the disclosure of decisions made by the Office of Residential Tenancies (Rentalsman's Office) to better protect the rights of both tenants and landlords;

- Continue to improve internet and cellular coverage throughout rural Saskatchewan;

- Introduce an Agriculture Value Added New Growth Incentive to attract more investment; and

Introduce a new Seniors Education

Property Tax Deferral Program that will give seniors with household incomes under \$70,000 the option to defer the education portion of property tax on their homes.

Our government also passed a bill allowing small business to pay less tax on more income. The bill extends the lower 2 per cent tax rate and gives employers greater incentive to hire more workers and invest in new capital here in Saskatchewan.

Our government recognizes the enormous contribution small business owners make to Saskatchewan, and we will continue to stand up for them.

These new tax measures mean Saskatchewan will soon have the highest small business income threshold in Canada, which builds on our government's record of creating one of the strongest investment climates in the country. We have achieved our province's first-ever AAA credit rating and, over the last decade, have boasted some the strongest national job and wage growth of all provinces.

BLACKSTRAP COVEANT CHURCH - PASTOR ANDY GILKINSON

We don't have many spaces in our year for reflection. However, many successful people know if they are to continue to be productive, there is a need for self-reflection. Bill Hybels said, "My biggest concern about leaders is their lack of reflection time. We stop asking who we are doing this work for, what kind of person we are becoming, and whether what we're doing is working." Whether or not you would consider yourself a leader in your life, there is a need to "consider your ways," as the prophet Haggai put it. Take a few moments to relax and consider the following questions.

1. What brought you and others life this past year? – What are the things that you have done over the past year that brought you a sense of life and joy? For myself,

this usually involves a combination of people and events. For example, this year I was able to watch my young son grow and develop from an infant into a toddler. I was also able to have a great vacation this summer with family members who we had not seen for some time due to distance. Regarding my work, I have seen people mature in their relationship with God. Consider how you might set your life up to spend more time in those areas that bring you joy.

2. What brought you and others pain this year? – Not all pain is bad. Pain can bring about some lessons and realizations that help us to be better spouses, parents and neighbours. I know that personally, I have made some mistakes in the past year that could have gone a lot differently if I

changed my approach to the situation. Take some time to admit your wrongdoing to God and others and seek to bring restoration to whatever the situation is.

3. How can I live my life with Jesus more intentionally? – For some of you, this question may seem unrelated to real life. However, this is not how Jesus thought of it. Jesus said, "I have come that [people] may have life, and have it to the full" (John 10:10). Jesus invites us to experience true living in himself. For some of you, this may involve going to or returning to church. For others of you, this may involve deepening your relationship with Jesus in prayer or Scripture reading. As we enter into 2018, let us consider our ways and experience more deeply the gracious and wonderful life that is found in Jesus.

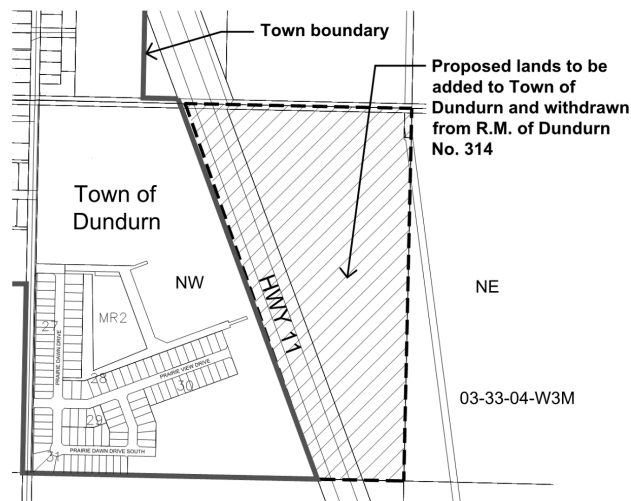
