

## BYLAW 2017-11

### A BYLAW TO FIX THE SANITARY SEWER AND SEWER INFRASTRUCTURE RATES

---

The Council of the Town of Dundurn in the Province of Saskatchewan enacts as follows:

1. **Billings**
  - a) Accounts for sewer service shall cover a period of one month. Accounts shall be paid by the 25<sup>th</sup> day of the next month.
  - b) The penalty on all accounts with sewer service that is unpaid after the 25<sup>th</sup> of the next month shall be 2% of the arrears on the combined amount per month and the water and/or sewer service may be shut off.
  - c) When the water and/or sewer service is so shut off, it shall not be resumed until all arrears have been paid together with a reconnection fee of \$100.00.
2. All premises with a water meter installed shall pay the sewer charges as set forth in Schedule 'A' regardless of usage.
3. The charges to be paid by the Consumer for sewer service shall be those set forth in Schedule 'A' attached hereto.
4. Persons who own or occupy premises drained or that are by Bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule 'A' attached hereto.
5. Every property with a current connection shall pay an infrastructure levy as set forth in Schedule 'B' attached hereto and all costs shall be born unto the property owner.
6. A levy to a property owner for a new sewer connection on a previously un-serviced lot in a developed sub-division, shall be as set forth in Schedule 'C', attached hereto.
7. The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee, or January 1<sup>st</sup>, 2018, whichever is the later.
8. Bylaw 2015-11 is hereby repealed on the date Bylaw 2017-11 comes into force.

**MONTHLY SEWER SERVICE CHARGES**

Residential	\$28.78 Flat fee
Multi-Residential	\$28.78 Flat fee per unit or apartment
Commercial	\$ 3.87 per cubic meter based on water consumption with a minimum charge of \$28.78.

\* Commercial is defined as Retail, Institutional/Public Facilities, Schools, Churches, Restaurants, Supermarkets, Industrial Facilities/Businesses and Hospitals.

**SEWER INFRASTRUCTURE RATE**

One-time payment:

\$1,755.00 per existing water connection (to have been paid in full by December 31, 2011):

OR

\$2,401.20 payable by 180 equal monthly installment payments of \$13.34 per existing sewer connection from September 1st, 2011 to August 31, 2026 extendable by any months non-billed.

**SEWER INFRASTRUCTURE LEVY - NEW CONNECTIONS**

One-time payment

\$1,800 payable for any new sewer service from the main to the property line on a previously un-serviced lot in a developed sub-division.
