The new **Animal Control Bylaw** 2023-08 came into effect on January 9, 2024. Common concerns in town are dogs running at large or nuisance barking. The new bylaw requires every pet must be licensed and is now **free of charge**. Please drop by the office and license your pet. If you need a replacement tag, they are available for \$5 per pet.

The Town is accepting applications for an **Animal Control Officer (ACO)**To find out more information or read the full posting, check out our website or call the Town office.

The **Bylaw Enforcement Officer** will be enforcing our municipal bylaws starting in May. See complete bylaws on our website or call the Town office if you have questions; 306-492-2202.

Spring is here and everyone is excited to be outside. The Town Traffic Bylaw allows operators **16 years of age and older** to operate an ATV on a direct route to and from a destination point within the Town, no general riding up and down streets or stunting is permitted. ATV's must **not exceed 30km/hour**. Riders be safe and considerate of citizens and children so all can enjoy the outdoors!
