2025 Property Reassessments

This year, 2025 is a Reassessment Year in Saskatchewan. A reassessment of all property classes is required by provincial legislation at least every four years to ensure property values are up-to-date, accurate and fair. This marks the beginning of the current four-year assessment cycle (2025-2028).

As municipalities are required to run on a revenue neutral basis, reassessments usually lead to the redistribution of which properties pay more or less, depending on their assessment changes relative to the average. Which means, the total property taxes collected will remain relatively constant factoring in incremental growth in expenditures, some properties will see an increase in taxes, while others may decrease based on that average assessment amount.

Please watch your mail for the assessment notices once the Town receives them from the Provincial Assessor (SAMA). The Town will also provide some informational notices throughout the process the help you understand the changes and their impacts on your property.
